**THE INSTRUCTIONS FOR MEMBERS FOR REMOTE E-VOTING AND JOINING GENERAL MEETING ARE AS UNDER:-**

The remote e-voting period will commence on Monday, 12<sup>th</sup> February, 2024 at 09:00 A.M. and ends on Wednesday, 14<sup>th</sup> February, 2024 at 05:00 P.M. The members will not be able to cast their vote electronically beyond the date and time mentioned above and the remote e-voting module shall be disabled by NSDL for voting thereafter. The Members, whose names appear in the Register of Members / Beneficial Owners as on the record date (cut-off date) i.e. 8<sup>th</sup> February, 2024, may cast their vote electronically. The voting right of shareholders shall be in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date being, 8<sup>th</sup> February, 2024. Once the vote on a resolution is casted by the member, he/she shall not be allowed to change it subsequently or cast the vote again.

**How do I vote electronically using NSDL e-Voting system?**

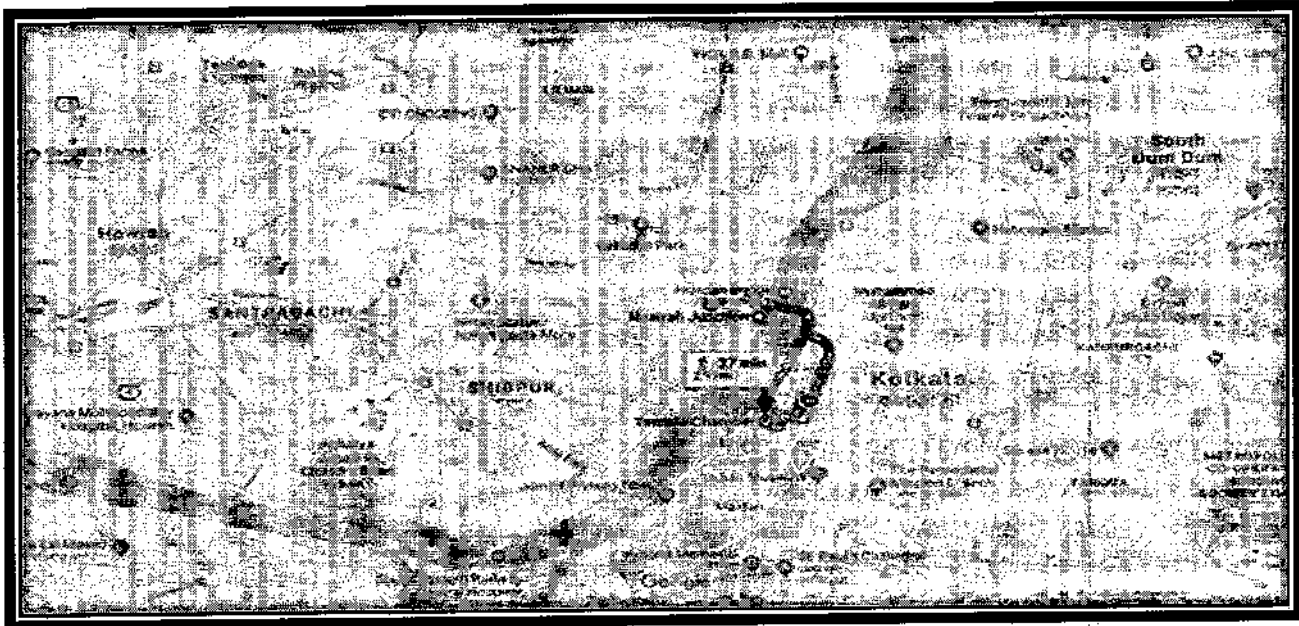
